The LRA Celebrates Buz Stone's 25 Years of Foundation Service

The LRA Labor Day meeting was a joyous celebration of the 25 years of inspiration, leadership and stewardship Buz Stone has provided for the Lake Rabun Foundation. It was an occasion filled with emotion, surprises and an outpouring of respect and appreciation for Buz.

In his resignation remark, Buz recalled the history of the Foundation. He talked about how the idea was originally conceived by Pete Halter and talked about the growth and success of the Foundation over the years. He was not aware that three of the people he mentioned in his remarks—Pete Halter, LRA President 25 years ago, Melanie Deitz, the first scholarship recipient, and Sam Wilson, a 2001 scholar who had made a generous contribution to the Foundation—were all there to be part of the program to thank and honor Buz.

Buz was presented a plaque thanking him for his 25 years of providing scholarship assistance and serving the needs of Rabun County. Then Ron Hinson and Lisa Longino announced that LRA members had contributed \$75,000 to establish and endow the Buz Stone "Lake Rabun Cares" Award. Buz will be the first recipient of this annual award and will be directing a \$2500 grant to Foxfire, which is the charity he has selected. In addition, a permanent plaque honoring Buz has been installed at the Pavilion.

Thanks to the leadership Buz has provided, the Lake Rabun Foundation has awarded almost \$700,000 in scholarship assistance in Rabun County. In recent years approximately \$50,00 is awarded each year to Rabun students. The LRA Scholarships awards are held in high regard in the Rabun Community.

In addition, another \$400.000 has been granted to a variety of charitable endeavors in Rabun County.

LRA members can be proud of what has been accomplished in response to the original plan of Pete and Buz to help the lake community "give back" and become better citizens of this special place we all love.

The Tallulah River Watershed Council Announces TWO MAJOR DEVELOPMENTS

The Tallulah River Watershed Council (TRWC) recently made two announcements about activities which will address questions many Rabun County residents have had regarding water quality in the Tallulah River and the lakes in its watershed. For several years, concerns about chemical pollution and increases in sedimentation have been building, but little concrete evidence had been gathered to answer those concerns. That situation has changed.

Georgia Power conducts extensive water quality testing three times per year throughout the watershed. However, the extensive list of factors tested does not include herbicides, pesticides and fungicides. And as large-scale golf course and residential community development began, particularly on Lake Burton, worry about the "cides" washing into the watershed intensified.

Also, with its many unpaved roads and untended shorelines, the watershed is quite exposed to sediment wash into the waterways. And some developers are less observant of proper silt-fencing practices than others. Are the lake floors rising? No hard data has been available to answer that question.

Now, at least in Lake Burton, one of those questions has been answered, and the other will be answered shortly.



With funding from the Lake Burton Civic Association, the TRWC engaged an independent and highly-qualified organization to test 6 different locations throughout the lake for the possible presence of 62 different analytes, representing virtually a complete list of the possible herbicides, fungicides and pesticides that might have been used and possibly washed inappropriately into the lake. And the testing revealed that there were no detectable levels of any of the 62 analytes in the water samples. That bears repeating, there were no detectable levels of any of the chemicals that had worried people for years.

Now residents know they can safely swim in the waters of Lake Burton. They also know that if any of the analytes are present, they are at levels well below what is permissible even for drinking water.

What about sedimentation buildup? The answer to that question will be answered soon. TRWC officials met with senior representatives of Georgia Power, and the result of their discussion is that Georgia Power has begun shooting the elevations of various lake floor locations. The data from this initial measurement, which was shot only in Lake Burton, will not answer the question, but subsequent measurements next year and the years that follow will. By next fall, the TRWC will have data regarding how much, if any, the lake floors have filled in (or receded). Over time, the measurement process will be altered, depending on what results it reveals.

These are exciting results that will help residents know more about the status of the geographic treasure we are fortunate enough to inhabit. The more we know about the status of our environment, the more comfortable we can be while enjoying it.

Letter to the Editor from Buz Stone to The Clayton Tribune

Dear editor,

I was recently honored by the Lake Rabun Association for having served as the Director of its Foundation for 25 years. How they honored me was so very thoughtful. They raised a large sum of money to create a separate Foundation. From this new foundation, \$2,500 will be donated each year to a charitable cause in Rabun County, FOREVER.. Who will receive the \$2,500 each year? That's the fun part. The Lake Rabun Association will pick someone within its ranks who has been actively involved in the community. That person can give it to whatever non-profit in Rabun County they desire.

I am the person they selected this first year. So, it has been my privilege for the past month to ponder who or what I should give the money to......

Call it Divine Providence, but a couple of weeks ago, I was meeting with some community leaders, and the discussion centered on what could be done to bring this County out of its economic malaise. The conclusion seemed unanimous tourism. Tourism creates jobs .Rabun County should be the envy of nearly every county in the State with it National and State Parks, mountains, trout streams, lakes, trails, waterfalls, and its Appalachian heritage, just to name a few of its assets. I remember in my youth, fishing in its streams and buck dancing in the ole chicken house up in Mountain City and "tubing" in those black inner tubes on the lake.

There is also the nationally renown Foxfire teaching method, which could attract teachers from all over to our County if the facilities were adequate to house and conference them. There is more. Time to Treat Hemlocks

Spring and summer 2012 were very active seasons for the hemlock woolly adelgids (HWA's) infesting our hemlocks. Unfortunately, the HWA's remain

active throughout the winter. Don't wait until spring 2013 to treat your hemlocks and risk returning to the lake to find your hemlocks in worsened condition. Fall is the second best time of the year to treat and you still have time.



Imidacloprid and water safety

As we are a lakeside and streamside community, many of you have inquired regarding the use of Imidacloprid, the primary active ingredient used for treatment of the HWA's, near the water. UGA researcher Mark Dalusky has shared: "Most of the published studies were conducted on agricultural soils and agricultural applications. Proper application in a forested setting is a horse of a different color entirely." Imidacloprid has a high binding potential to organic matter; agricultural soils typically have very low organic content, in the 3-6% range. By contrast, where hemlock treatment is placed shallowly in the root mat within 12-18 inches of the trunk, the organic content is huge and the binding potential is very high.

Soil column studies by Bayer in which the soil column mimicked the soil profile under forested conditions, showed that Imidacloprid moved very little from the point of injection (<20cm). The U. S. Forest Service conducted Environmental Analyses for both imidacloprid and (more recently) Dinotefuran. They supported the Bayer findings regarding leaching potential in forest soils.

A 2-year UGA study in 4 forested drainage areas produced similar results — no trace of chemical in stream water and no negative impact on the resident aquatic insects, which are very sensitive to Imidacloprid and therefore good indicators of contamination.

The keys to water safety are to follow the label and to use good common sense:

- Don't spray it when there is any breeze.
- Don't apply it directly to water or to areas where surface water is present.
- Don't apply it to soils that are very porous, sandy, gravelly, or cobbly, particularly if the water table is shallow.
- Don't apply it to soils that are water-logged, saturated, or frozen.

New LRA Hemlock Program Leader

Bob Pledger, who began the LRA hemlock initiative several years ago, will remain as an active LRA Hemlock Facilitator, however, the reins and leadership of the LRA Hemlock Program have been turned over to Buz Stone who will also be handling the LRA soil injector reservations and loan out program. As in the past, check the LRA website under the Hemlock Program tab for a list of our LRA Hemlock Facilitators who are ready to visit with you and provide guidance and counsel to help preserve your hemlocks.
