## Lake Rabun Association General Membership Meeting May 28, 2006

## 1. Welcome/General Comments:

- a. LRA President, Kirk Knous, called the meeting to order at 10:09
- b. Kirk reads the names of the member of the LRA who have passed away since our last meeting.
- c. Warren Huddleston, Pastor of Clayton First Methodist Church, opened the meeting in prayer.
- d. Kirk asks that new members stand and introduce themselves.
- e. The reading of the minutes of the last meeting is waived.

## 2. Reports:

- g. Chris Clay speaks as President of the Rabun Co. Builders Association about some of the new developments in building practices in the county.
- h. Alan Price states that a new law has been passed to limit the length of boats on Lake Rabun (as well as other lakes) to 30 ft.
