Lake Rabun Association General Membership Meeting August 31, 2008

Welcome/General Comments:

LRA President Bob Voyles called the meeting to order and welcomed attendees.

Carol Cook, Pastor of 1st United Methodist Church of Clayton, gave the invocation.

Bob then led the pledge of allegiance to the flag of the United States of America.

- 5. Mountain Patrol Craig Ness was recognized for his work and spoke of his new position as Animal Control Officer for Rabun County. A bucket was passed to collect an appreciation gift for Craig.
- 6. Hall's Boat House Charlie Arp thanked the members for a great year.
- 7. Joe Hamilton introduced Ted Mashburn (VFD) and Ted thanked the membership for supporting him through his medical issue.

Whippoorwill Award

Roses Longino presented this year's Whippoorwill Award to Charlie Arp and recognized his many contributions to the lake community over the past 30 years.

LRA Foundation Report

Buz Stone gave a Foundation report, including a brief history of the Foundation. We are currently supporting 26 students and other local community needs.

Officer's Reports:

A. Chairman's report

Kirk Knous introduced the local politicians/candidates that were at the meeting. Kirk noted the continuing property tax issues and the need to register to vote to make a difference in Rabun County.

B. Vice-Chairman's report

Thad recognized Kirk for his contributions to the LRA and the local community and presented him with his LRA Trustee boat paddle.

E. Secretary/Treasurer report

The Trustees voted to hold dues at \$200 per year, but assess a \$50 late fee for dues not paid by December 31.

Rick Asbill reported that the Lake Rabun Pavilion mortgage had been paid in full and recognized the number of donors and those involved in the project. A "burning of the mortgage" ceremony was held complete with fire support from the LWVFD.

New Business:
