Lake Rabun Association General Membership Meeting May 24, 2009

- 1. President Nan Troutman welcomed everyone and introduced Boy Scout Troop 40 who presented the Flag and the pledge of allegiance. She recognized military veterans at the meeting who had served in the Army, Navy, Air Force, Marines, Coast Guard and the families of those serving currently in the service of our country, and asked for a moment of silence.
