**LWVFD** John Widgery announced the Fire Wise program which is an educational service designed to help home owners protect their homes from fire. He stated that many of the homes on the lake were surrounded by overgrown vegetation which would make fire fighting difficult, if not impossible.

Ron Hinson and Bob Voyles met with representatives of the Tallulah River Watershed Task Force about their efforts to protect the area lakes. More information will be forthcoming.
