Secretary: Ruddy Deas: No Report

Chief Financial Officer: Anita Pittman

2017 was very successful financially as we raised more than ever before. We raised over \$10,000 in merchandise and Centennial books and DVD's which have been significantly

reduced in price to move inventory. Rabun Ramble raised over \$20,000 and the Market raised \$135,000. Expenses are tracking forecast except for lower than anticipated sales tax voluntary disclosure settlement. Cash flow is higher than originally forecast. Financial statements attached.

Foundation Report: Steve Raeber

Thanks for all the support this year which was very successful. We have 13 new scholars this year, which combined with past scholars totals 35 for \$70,000 in total scholarships. Projected to give over 40 Rabun County charities \$40,000 for best year ever. As projected, we will have given over \$110,000 in total back to the community in 2017. Thanks also to those who have established and funded named scholarships.

The Market at Lake Rabun: Betsy Bairstow and Penny Burkitt

Over \$135,000 raised which is most ever for this fundraiser. All committee heads were recognized and funds raised will be equally divided among the foundation's Lake Rabun Fund and Lakemont Wiley Volunteer Fire Department's (LWVFD) Capital Fund.

Rabun Ramble: Sandy O'Brien Strong

The 11th Annual Rabun Ramble raised over \$20,000, the best year ever due primarily to more sponsors. Thanks to LWVFD and Rabun County EMS for responses during recent medical emergency at the ramble. Will have ambulance on site next year. Next ramble will be held June 30,2018.

Cookbook: Anne Pledger

Halfway through recipe selections after recipe parties and photo shoots which will continue in October. Need volunteers for October parties and most appreciative of those who edited and tested recipes.

Fire Boat Update: Bob Pledger

Last Labor Day we initiated a capital campaign to raise funds for a new fire boat to maintain low fire insurance rates and provide better fire protection. To date we have raised \$157,000 from 134 contributors plus the \$57,500 allocated from The Market for a total raised of \$214,500. We have developed boat specifications and selected a manufacturer with a total boat and equipment cost currently estimated at \$228,000 or approximately \$243,000 including needed boat house renovations. We have met with some of the county commissioners in an effort to gain the additional \$29,000 needed to order the fireboat. We plan on meeting all the commissioners in late September and gain their commitment so we can order the fireboat. We Successfully answered many questions and feel very good about gaining their commitment. We will need your presence at that county commissioners meeting to gain their support and will inform LRA members as to specifics shortly.

Whippoorwill Award Presentation: Carol Raeber

This years recipient is Barbara Roper who was unfortunately out of town but represented by her son. Barbara's many lake oriented activities were noted. We will establish a new Whippersnapper award for a younger person whose dedication and work deserves recognition.

Fred Stewart Award Presentations: John Williams

This year we have two separate awards. On June 8,2017 a van ran off the road near Ayers Road, overturned about 30 feet off the road with the sole female driver held upside down by her seatbelt. Dr. Jack Dickens was following the van, saw the accident, cut the driver loose and returned her to the roadbed without injury. The second incident occurred during the Rabun Ramble when a members daughter had a heart attack during the race. Her accompanying friend Anne Marie Hoffman and John Polhill applied CPR until Dr. Bill Davis' AED was used numerous times. The daughter recovered without apparent damage. All four of these named individuals received this award for their timely and effective action, which averted major consequences.

Recognition of Web Masters: John Williams

Presents were given to Tim and Veanne Smith for establishing and maintaining our website over the years.

Recognition of Officers:

Presents were given to outgoing Chairman and President for their service and the gavel was officially passed to the incoming president-Sandy O'Brien Strong.
